Although the company is taking prudent steps to impose and enforce appropriate protocols to keep our customers and staff safe, there can be no assurance that the Virus will not be contracted by the meeting, event and hotel attendees described herein. That is a risk that you must assess for yourself and your family: if you choose to attend the hotel for any of the services described herein, you are assuming the risk of contracting the Virus and of then transmitting it to others.
